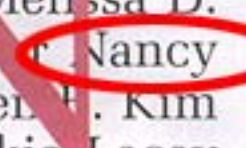
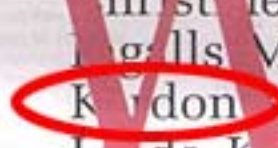

Year in Review: After 11 years as a federal prosecutor and four years as an associate at Paul Hastings, Kardon struck out on her own, winning a summer

2008 federal jury trial for Deon Edward Lopez, who was acquitted of all charges in a drug trafficking and gun possession case. Lopez, who faced a mandatory 15-year prison sentence if convicted and had spent two years in federal custody before trial, previously had turned down a plea agreement with the government.

Next Challenge: In federal court, Kardon is representing clients facing Medicare fraud and narcotics trafficking and drug charges. In state court, she continues working on domestic violence, assault and other cases.

Most People Don't Know: Before becoming a lawyer, Kardon skied on the Italian National Ski Team and met Olympic gold medalist Alberto Tomba. She also is a certified yoga instructor.
